

Terms and Conditions

The following Terms and Conditions apply to all bookings made. We kindly ask that you take a moment to read them prior to making a Booking.

In these Terms and Conditions the following definitions apply:

“The Agreement” is your Booking Confirmation and the Terms and Conditions;

“The Hotel” is the premises for which your Booking is made;

“The Owner” is the Owner of the Hotel as mentioned on the booking confirmation;

“The Booking(s)” includes accommodation & breakfast.

“The Guest(s)” is the person, company, organisation or other body responsible for making the Booking;

Bookings

Guests may book in advance or on arrival. Rooms are subject to availability and the Hotel reserves the right to refuse any Booking for good reason. Although payment is generally required on departure, there may be occasions when the Guests are required to fully prepay or provide a deposit at the time of the Booking, or, on arrival at The Hotel.

Charges

The prices displayed on the website are a total for your requested stay. A minimum length of stay, deposit, cancellation charge and other conditions may apply to certain rates, as specified.

Payment

You will be asked to provide a credit card (or debit card) at the time of the Booking to secure your reservation. By booking you are authorising the debiting of the card provided.

The Guest must pay all outstanding charges on departure from the Hotel.

Deposit

A deposit of £50 for each room reserved is required.

Cancellation/ Non-Arrival

Room bookings cancelled 8 – 14 days prior to date of arrival will result in loss of Deposit and this will be charged to the credit/debit card authorised upon booking. Any bookings cancelled within 7 days of arrival will be subject to loss of deposit and, if we cannot re-let the room(s), we reserve the right to charge the remainder of the booking to the Credit/Debit card authorised at the time the booking was made, .

Change of Booking Details

Where the Booking permits, any change to the arrival date, departure date or room type is subject to availability at the time the change is requested and may result in a possible rate change.

Arrival and Departure

Guests may check-in at any time from 2.00 p.m. on the day of arrival. All rooms that have been secured by credit / debit card or prepaid at the time of booking will be held until 12.00 noon on the following day.

On the day of departure we kindly ask all guests to vacate their rooms by 10.30 (unless a later departure is stated as part of your booking). Late check-out after this time can be requested subject to availability.

Parking

There is limited availability at the Hotel, but we do provide permits for the nearby car park, we just ask for £10 deposit which is refunded on return of the permit.
